Dear Friends,

As this year draws to an end and yet another one begins, I find myself asking: "If not now, when?" The first time I attended Atlanta Friends Meeting, on Easter several years ago, I felt that I had come home. And yet I did not apply for membership. Why? Many reasons have come to mind, but few have been at all compelling and all have fallen away except one: procrastination. Talking with F/friends and seeing many of them join AFM, I have realized that it is time to end my procrastination. So I am (finally) asking for membership.

I grew up in the Methodist church, which I attended every Sunday and Wednesday until I left for college. At times I felt very close to the church and at other times I felt very keenly the hypocrisy of those who "preached" equality but actively discouraged blacks from attending. I then spent several years without attending any church before I found myself on a Methodist mission station in Zaire (the Congo) and once again started attending church services. The actual services were hard to follow since my Swahili never reached the required level, but the missionaries all truly lived their beliefs and radiated happiness and the sense that they knew they were exactly where they belonged. The prayer group was awesome, and it was in French so I had no trouble following. Teachers, theology school students, missionaries, high school students, anyone interested was welcomed. We shared any thought or question or belief, knowing it would be lovingly heard and discussed within the group, but never to those not in the group. We grew very close. To each other and to God.

After six years at the Methodist station I came back to the States on a one-year furlough, during which I planned to obtain a Masters at Emory and try out living in the U.S. again, so I could decide whether to spend the rest of my life in Africa. During my year at Emory I attended the Methodist church where I met

George. While I did finish my degree, I did not return to Africa when the year was up because by that time I was married and pregnant. We continued to attend the Methodist church until our children graduated from high school. Once again I had become uncomfortable with the hypocrisy I perceived and the amount of the budget spent on our own services and comfort rather than on helping the less fortunate. So when George stopped attending church, I stopped with him.

After several years not attending church I felt the need to find a spiritual home. While I was researching possibilities I thought of my paternal Grandmother. She was the woman I most admired growing up, even though I seldom spent time with her because we lived so far apart. She was a Quaker, as were her ancestors going back at least 300 years. Although she had lived a hard life, she had an inner calmness and a depth of faith that I wanted. So I looked up Quakers online and found the Atlanta Friends Meeting not five miles from our house. I felt it was meant to be. The first meeting I attended felt like I was returning home. George attended for a few years before losing interest, but this time I continued to attend without him.

The people at Atlanta Friends Meeting feel real, comfortable being who they are, and live with integrity. They lovingly accept people with many different beliefs, but all seem to believe in the goodness of humankind. While some people clearly have very strongly held beliefs, I feel no judgment by those whose beliefs are different. Atlanta Friends Meeting feels like a warm, loving, truthful, accepting place where each one is seeking to learn, to listen to the guide within and to be the best person he or she can. I am happy here and proud to be a part of a wonderful, loving family. I feel it is time that I make my relationship with the Quakers official and I humbly request membership in Atlanta Friends Meeting.

envision keeping a connection with AFM while starting an Evangelical Friends Church that would meet after AFM worship, most likely in the Clarkston/Stone Mountain area, and serve to bring together African refugees and immigrants from different ethnic and national groups. During his visit, Dr. Evans will meet members of the Burundian community at potluck and then meet with an ad hoc committee from AFM including the Clerk, representatives from Ministry & Worship, Care & Counsel, and three representatives from the Burundian families. Courtney Parker Siceloff

Courtney Siceloff was born January 4, 1922 to John Andrew Siceloff and Mary Margaret Powell, and died on January 28, 2014.

Born the son of a Methodist minister who moved every 3 or4 years to small towns in north Texas, he learned to make friends wherever he was. At Southwest Methodist College in the early '40s, he became involved in discussions with a Methodist student movement to understand problems of racism and pacifism, and joined a peace caravan led by AJ Muste and Bayard Rustin. Graduating in 1943 from Haverford College when most of the young men he knew volunteered for World War II, Courtney chose to be a conscientious objector working for Civilian Public Service in forestry camps, before volunteering in 1946 for the UN Relief effort to send cattle to Europe. He worked for AFSC for several years in the south of France in post-war reconstruction and support for refugee populations. Courtney met his future wife, Elizabeth Taylor, on a Quaker study tour to Scandinavia and they were married in 1949.

In 1950 Courtney and his wife Elizabeth traveled to the small community of Frogmore (now St. Helena), South Carolina, a place they would call home for almost two decades. Courtney became the director of Penn Center, previously Penn School, founded in 1862 to educate newly freed slaves as teachers and artisans. Under his leadership it thrived as a community development center and a vital link in the fight for civil rights in the South. In the early 60's, the Southern Christian Leadership Conference held retreats there and Martin Luther King Jr. visited several times. A racially diverse staff of talented community organizers and activists worked in health care, property ownership and farm cooperatives.

In 1969, Courtney resigned from Penn to open the way for a new generation of leadership, and accepted a position as Deputy Director of the Peace Corps in Afghanistan. The family lived in Kabul, Afghanistan for four years. During this period Courtney and his team worked to provide education and health care in villages across the country.

The Siceloffs moved to Atlanta in 1973, and Courtney worked with the U.S. Commission on Civil Rights meeting community groups across the south to ensure projects receiving federal funds were free of racial bias. Courtney became a member of the Atlanta Friends Meeting serving in many ways including presiding clerk, the construction and move to a larger meeting house, and the start of a Friends school. He educated and inspired Friends by his example of a constant, strong and gentle witness.

He also served on the Southeast Regional and National Executive Committee for AFSC. "We looked to Courtney for guidance in turbulent times and times of joy. His integrity, his pursuit of justice, his commitment to nonviolence and his Quaker capacity to find the good in everyone were luminous beacons to us all," said one of his fellow American Friends Service Committee members, former AFSC regional director Elizabeth Enloe of New York City.

Courtney and Elizabeth regularly attended Southern Appalachian Yearly Meeting and Friends General Conference Gathering. After his retirement, and well into his eighties, he continued to work for racial equality, for women's rights, for non-violence, and for the eradication of poverty. He often stood with other Friends in demonstrations holding a "war is not the answer" sign.

"Courtney was so compassionate," said a friend, Sally Ferguson of Atlanta. "He was touched by the plight of a homeless schizophrenic woman we knew who would scream and rant if she felt the slightest offense. Courtney built a two-room dwelling with heat and plumbing for her beneath the Siceloff family's back porch. For several years he or his wife would take a hot meal to her each evening. I think he appreciated the woman for allowing him to do good for her."

Courtney's loving wife of 53 years, Elizabeth Taylor Siceloff, passed away in 2003 and a son, John in 2015. He is survived by a daughter, Mary, in Savannah; and grandson, Andrew, in New York City; and an extended family of cousins, nieces and nephews, whose lives have all been enriched by Courtney's extraordinary life and his vision of a better world.
