## Mary Jane Simpson Scholarship Fund

The Mary Jane Simpson Scholarship Fund helps graduating seniors in DC public schools go to college. Quakers have been running the program for over thirty years. The fund is named for Mary Jane Simpson, a member of Friends Meeting of Washington and social worker in the DC public schools, who launched this fund and was its strong champion. Since 1981, this program has awarded 101 scholarships to graduates of 19 DC public high schools.

The Friends Meeting of Washington and Bethesda Friends Meeting jointly manage and finance this scholarship fund. A management committee from the two meetings contacts public schools, selects awardees, follows up with recipients, and makes decisions about the program's policies and practices.

J.E. McNeil and Anne Kendall from FMW will be at the 11/24 meeting to tell you about the the scholarship and the students who have received this help. We welcome the support of Langley in what we think is a very exciting project.

Friends, we are nearing the end of the Federal income tax year. We're also more than 1/3 of the way through Langley Hill's fiscal year. During the period July - October 2013, we budgeted to receive over \$18,400 in contributions *outside of AutoGive*. Unfortunately, we've received only \$4,544.

## Thoughts on Membership – from Oct. 27th Second Hour

#### Meaning of membership

- Commitment (x2)
- Public commitment (x2)
- Not unlike the commitment of marriage -- formal and public (x2)
- But some said commitment is not the same as membership and is more important (x3)
- "Real" members are those who are committed to the Meeting, not necessarily those who have been through a membership process
- An affirmation to give back to the Meeting, not just take from it (x3)
- Acceptance, responsibility, and accountability to and from the community
- A statement of responsibility for the health and life of the community
- Integrates one more closely into the Meeting
- Affirms community
- Friends open up more to members and include them more in Meeting activities
- Means being recognized as part of the community
- It's a public affirmation of belonging
- Should not change the way the Meeting thinks about the person (nonmembers are as valuable as members)
- Should not feel exclusionary
- It's intensely personal; it's one's identity (x2)
- It's a judgment of whether the Meeting can accept the applicant
- Carries responsibility to be articulate about what Quakerism is
- It's a mistake to think joining will enable someone to "fix" what's wrong with the Meeting
- Shouldn't be terminated no matter how tenuous the connection if the person wants to remain a member
- Confused about journey to become a Quaker vs. a member of a particular Meeting
- Should have a low bar on allegiance to testimonies (military, in the CIA, not a pacifist all okay).

But others said membership should not be extended to everyone (x2) (i.e. not pedophiles, "my way or the highway" evangelicals, or atheists, active soldiers, CIA employees, abusers of other people)

#### Membership process

- Helps both the Meeting and the applicant understand each other
- Is a process by which applicants teach themselves about basic Quaker processes and learn what they are getting into
- Should be a mutual process of exploring our spiritual and practical links with each other intended to help us understand and support each other as part of a community
- Is a process of reaching clearness, which is valuable regardless of the outcome
- Sheds light on all of one's character
- Should be an active, contemplative process between the applicant and the group
- Although it's hard to hear "This isn't ripe yet," that can be the wise response
- The Meeting should respect and nurture people on the journey to membership and help individuals discern this path
- Some fear they wouldn't "pass" the process despite an internal commitment to the Meeting
- Is intimidating
- Maybe we should say if you come, you belong.
- People can be hurt spiritually if they want to join and someone objects or if they want to serve in a particular position and can't because they are not members. We should not be causing spiritual hurt.
- A process of clearness when a person is working through the idea of joining is good, especially being held in the Light, but clearness is between an individual and God, and other Quakers should not be able to stand in the way of someone who is clear and wants to join.
- An alternative (better) process might begin with a letter and clearness committee to test the leading and hold in the Light, but if after these steps, if the applicant wants to join, he or she would be allowed to join.

### Our Quaker Quest Workshop Was a Success — Now What?

On October 26 about 30 members and attenders of Langley Hill including two young Friends were led through a marvelous spiritual experience by two expert facilitators from FGC. Our goal was to help find ways to talk about our faith and understand better some of the ways we can welcome newcomers into what can sometimes seem a closed community.

We practiced "Quaker speed dating," which is not a new Christian dating service, but an opportunity to share in 60 seconds with one other person your response to typical questions Seekers ask. Do Quaker believe in sacraments? How do Quakers view the Bible? How is worship and mediation different? Not surprisingly there were lots of different answers to these questions.

We also tossed a big ball of yarn around the circle to show our connections: "our kids were in FDS together," "we're on a committee together," "we sing together," "we have lunch after Meeting," or "we are in Spiritual Formation together." It's great to be involved as long as those connections don't become barriers to welcoming others into our community.

Finally, we spent time understanding what the outreach part of Quaker Quest would be like. As developed by British Friends and refined and supported by FGC, it involves an introduction to Quakerism by experiencing silent worship and hearing from three members or attenders of the Meeting about their past and current experience with a topic relevant to Quaker faith. Three consecutive sessions each have this format, and the series is repeated so those attending can experience all three events.

We heard from Mel Snyder and Hugo Estrada about their experiences with Simplicity for five minutes and then we got to reflect in small groups on what simplicity means to us.

To make the Public Sessions of Quaker Quest work, the Meeting would have to publicize the three sessions, which would be repeated, so we attract people curious about Quakers. We learned that there are in fact many Seekers that have an affinity to Quakerism according to research as they want a Spiritual home that gives them meaning and purpose and creates a sense of Community from which service and social action is fostered. Clearly Quaker Quest is a program and commitment that we are just beginning to explore.

Ministry & Worship and Advancement and Outreach have started talking about next steps. Are we led to pursue the public sessions of Quaker Quest? Ultimately this would require approval by the Meeting and significant involvement. If you are interested in being part of that discernment, let me know.

Alternatively, we may decide that outreach is still important but we will do it in other ways, or that our focus should be continuing the dialogue about our faith and going deeper.

Or all of the above, as way opens. The committees do sense an energy that was created by the Quaker Quest Workshop and we want to tap into it and let it spread throughout our Meeting.
