Hannah introduced the Outreach Committee's proposal for us to consider a program inspired by Quaker Quest, which was started by London Monthly Meeting, intended for Monthly Meetings to share their Light with their communities. Chad Dell of Manasquan has developed the new program and would like to introduce us to it. We will invite him to talk to us doing a Soup and Sharing followed by his introductory presentation. We will pursue January 7 as the date.

The Building Committee meets ay 7:30 p.m. Thursday at the Meetinghouse and is inviting members and attenders to offer thoughts about work done and other needs.

Hannah reported that Ministry & Counsel Committee finds that the current query Sunday experiment seems to be working. The committee will move ahead with it and continue to evaluate it.

Hannah said Friends Committee on National Legislation is recommending letters be written to Congress supporting the Iran agreement now challenged by President Trump's Administration.

We approved the use of the Meetinghouse for Shepherd's Play rehearsals beginning in November for the annual play on Dec. 16.

We ended with a period of silence at 12:30 p.m.

THOUGHTS ABOUT WORSHIP WITH A CONCERN FOR BUSINESS

Excerpts taken from the NYYM Faith and Practice:

Our attempt to treat all other persons with respect, integrity, and love informs our practice and concerns in all our lives, from close interpersonal relationships to the conduct of meetings for business, to the search for international peace. It may be that we shall find unity in Jesus's simple admonition to "Love one another as I have loved you"

Friends' business meetings are meetings for worship with a concern for business. When there seems to be disagreement, a free expression of all opinions should be encouraged. Those who speak in meetings for business are advised not to be unduly persistent in advocacy or opposition, but, after having fully expressed their views, to recognize the generally expressed sense of the meeting. A deep and seeking silence can help to reconcile seemingly opposing points of view. Meetings should be conducted in the spirit of wisdom, forbearance, and love.

OUR MEDITATION GARDEN: A PLACE OF REFLECTION, REMEMBRANCE, REPOSE

Having been a member of Poplar Ridge since 1989, it was, literally, for decades that I would walk out the back door of our meetinghouse, look at the end of the parking lot and see a beautiful garden – in my imagination! In reality, there was a tangle of brush and weeds.

Finally, in 2011, with permission from the community, a small group of us began working toward this vision, clearing out what was hidden there: rusted wheels and lots of old tires, broken cement and disintegrating bricks, old barrels - even a dismantled metal swing set!

The next year, we chipped the larger limbs and when the ground was clear we laid out a portion of a path, spread out the chips for mulch, and one sole tree was planted. Let us say, it was a slow start!

Things really got going in December 2015 when Leigh McGonagle, with her new Cornell degree in landscape architecture, responded to the call and offered her expertise. The wedding of Heidi Richter and Drew Schlichtmann in September 2016 became our focus and sustained work began.


In addition to a walking path and seating areas, the vision had expanded to include a labyrinth, and this was formed lovingly from stones from Andreas Richter's memorable stone collection.
