MINUTES FOR POPLAR RIDGE MONTHLY MEETING FOR BUSINESS APRIL 15, 2018

The Monthly Meeting opened with a period of worship about 11:30 a.m.; the minutes from the March meeting were read.

Attending were Ruth Bradley, David Connelly, Anne Dalton, Jim Frisch, Barry Kahn (by phone), Craig Kukuk, Jeff Layton, A.T. Miller, Suzanne O'Hara, Hannah Richter, Christopher Sammond, Andy Simkin, Jane Simkin, Karen Simkin, Linda Simkin, Paul Simkin, and Charlie Weld.

We approved a returning membership transfer request for Phyllis Rantanen Bunker from the Guatemala Meeting where she had been for 36 years. That meeting is being laid down. Ministry and Council considered that she should be welcomed into membership as soon as possible.

Ruth reported for the Gardens Committee that it needs approval to receive earmarked contributions for maintenance purchases for this year. We agreed.

Suzanne requested that the meeting consider using other website hosting services than the one we have been using. She has been having difficulties with it. They could cost as much as \$120 annually. We approved her looking into hosting services from New York Yearly Meeting and others and making a decision on the best route.

We accepted a request from Donna Beckwith, on the Farmington-Scipio Regional Meeting Ministry and Council Committee, for us to host an extended meeting for worship and potluck for the Regional meeting on a Saturday in October. We will discuss with her the date, preferably the 13th or 20th.

We approved the appointments as recommended by the Nominating Committee, as attached to these minutes.

We appointed Christopher Sammond to the Nominating Committee to serve until 2022.

We received reports from the following committees: Building and Grounds, Gardens, Bulletin Board, Finance, Library, Membership, Outreach, PRISM Nominating, Peace and Social Action, Social, Telephone Tree. Other reports include the Statistician's report (Karen Simkin) and Wider Parish Representatives (Jane Simkin and Sally Otis).

Religious Education / Youth Committee's report will be submitted after the Children's Day in June.

Jim Frisch read the report of the Farmington-Scipio Regional Prison Committee, prepare Jill McLellan. Our Prison Worship Group Contacts are Jim Frisch and Dill Otis. Ann read the report of that group.

We began a discussion about consolidating Phone Tree/Directory, Webmaster, and Facebook Contacts under a single Communications Committee. We will refer the idea to participants in the four committees. Sally Otis will be asked to convene a meeting to further that discussion.

There will be no May Meeting for Business.

We closed with silence at 1:45 p.m.
