**MINUTES FOR POPLAR RIDGE
MONTHLY MEETING FOR BUSINESS
JULY 21, 2019**

Present: Paul Simkin, Donald Simkin, Jane Simkin, David Connelley, Sigrid Mortensen, Dill Otis, Suzanne O'Hara, Andy Simkin, Hannah Richter, Charlie Weld, Howard Nelson, Craig Kukuk, Christopher Sammond, Barry Kahn.

Meeting began with some silence. June minutes were read. Christopher said that he was requesting more specifically than indicated in the minutes that we have two people, one from the Finance Committee and one from Ministry & Counsel Committee, attend the "Creating Generous Congregations" workshop; he was not requesting financial support for whoever might go. He considers the workshop an extremely valuable one. So far no one has stepped forward as able to attend.

Treasurer's Report. Ruth reported that we are close to 32% on donations so far this year: \$24,959 of \$46,706. Hannah asked that we have bar graphs made to show our progress, as has been done in the past. Ruth said that she is planning to do that.



Ministry & Counsel: Charlie gave an update on the membership request of Dean Faiello, as prisoner at CCF. We need to submit a letter from the Clerk to Imam Saad, who is facilitating the clearness process. Hannah will send this.

M&C, second item: Charlie distributed a handout on NYYM's Alternative Pathways to Membership Proposal (draft) (see below, attached). Charlie reviewed the current process, as outlined in detail in

Faith & Practice. The proposal, which was sent by Emily Provance, clerk of the Ministry Coordinating Committee of NYYM, recommends changes to Faith & Practice that would allow prospective members to apply directly to NYYM for membership, rather than to a particular monthly meeting. M&C has discussed the proposal in its recent meetings, with the outcome of reservations about the proposal. There was a strong feeling that Monthly Meeting worship is central and should not be bypassed in the membership process, and that dealing with differences a person may have with the monthly meeting is valuable. Charlie reviewed options for responding to the NYYM work group regarding the proposal. M&C now asks for input from our meeting. Extended discussion ensued. It was expressed that the situation of people who live where there is no monthly meeting nearby is a special concern. Others said in various ways that worship experience at a monthly meeting should remain a crucial criterion, that "work arounds" of established practice are not desirable, and that working through the process is valuable. Other points raised were that technological changes may be a means of addressing the problem; that "Wider Quaker Fellowship," an existing provision, might speak to the need being expressed; that physical disabilities play a part in the question; and that it is important "not to say no" and instead find ways to accommodate people's desire for change.

Hannah asked if we could use M&C's concerns as expressed in the hand-out as our response. It was agreed that many of us share M&C's reservations about the draft's proposal, but that we also recognize the importance of the concerns, particularly the aspect of physical isolation. We would suggest as alternatives to the proposal that individuals work on their own or with the support of Monthly, Quarterly, and Yearly Meeting resources to find or found a worship meeting, or seek out Wider Quaker Fellowship. It was approved for the Clerk to communicate this to Emily Provance. It was noted that we are doing so in order to meet the deadline, but with a feeling that the issue of membership is a serious one and should not be rushed.

Building Committee: parking lot project: Andy and Dill reported that there is a need to replace the septic tank. In consultation with the excavating contractor, a request has been made for Health Dept inspection for tank replacement. Pumping will be

required prior to installation. Andy and Dill were given authority to take relevant actions to move the project forward.

Announcements: Hannah received a request from Kristen Brennan. Her church in Ithaca is working on becoming a sanctuary church and asks for financial support. It was agreed that her request should be forwarded to Peace & Social Action Committee for consideration, which will report back to monthly meeting before any action is taken or public announcements are made.

Sigrid said that the Music Committee is researching the possible need for more hymnals. Meeting ended with a period of silence. Hannah thanked those present for their attendance and attention on a hot summer day.

NYYM’S ALTERNATIVE PATHWAYS TO MEMBERSHIP PROPOSAL (DRAFT)

In April, 2019, Emily Provance, clerk of the Ministry Coordinating Committee of NYYM sent several documents to the PRMM clerk, describing work that has been underway since 2016 in various committees and work groups in NYYM to discern the need for and construct an alternative pathway to membership in

the Religious Society of Friends. The NYYM Ministry Coordinating Committee had identified barriers preventing seekers from joining Quakerism through application to a Monthly Meeting as has been the practice in NYYM. These included incarceration, differences in culture, scheduling conflicts, distance from a Monthly Meeting, caretaking duties, and inability of a local meeting to speak to a person’s spiritual condition. The Ministry Coordinating Committee concluded that, given these obstacles, there needed to be a new way to become a Friend, more flexible than that described in NYYM’s Faith and Practice. The following proposed changes to NYYM’s Faith and Practice would allow prospective members to apply directly to NYYM for membership:

******MEMBERSHIP THROUGH NEW YORK YEARLY MEETING.**

The prospective member is actively involved in New York Yearly Meeting business, committees, communities, worship, events or sessions. Sometimes life circumstances make it difficult or impossible to regularly attend or join a monthly meeting: reasons include, but are not limited to, those living in remote locations, caregivers, incarcerated persons or those not finding a spiritual home in an adjacent monthly meeting. Those seeking membership should be prepared to give resources of time and/or money and participate in the work of the Yearly Meeting or its committees, task groups, Sessions, and Powell House. A commitment to enter wholeheartedly into the spiritual and corporate activities of the Society and to assume responsibility, as way opens, is expected.

APPLICATION THROUGH NEW YORK YEARLY MEETING FOR MEMBERSHIP

The prospective Friend should write a letter addressed to the clerk of Ministry and Pastoral Care Committee of New York Yearly Meeting stating the reasons for joining the Religious Society of Friends and why membership under the care of New York Yearly Meeting is sought at this time, rather than monthly meeting membership. The letter should include how the applicant is in unity with Friends testimonies and principles, and how the applicant envisions being involved in New York Yearly Meeting. ****

These proposed changes were discussed at PRMM’s Ministry and Counsel Committee, and concerns were

expressed by members of the committee. One concern was our sense that regular worship in a Quaker community (i.e. a monthly meeting) is the activity that informs all other Quaker activities, and is the foundation that other Quaker activities are built on. By opening membership to persons that may know Friends primarily through participation in NYYM activities, that may or may not include Quaker worship, this connection to worship may be lost or may be unable to be realized.

As we read the extensive proposal and accompanying documents, we understood that a person who has had favorable experiences at summer sessions or Powell House would be free to seek membership in the RSOF through the Yearly Meeting, even without ever having had a relationship with a monthly meeting. This practice would enable someone to join Friends without the benefit of being in the life of a monthly meeting. We believe that there is a great benefit from the wrestling each one of us does in the day to day life of a monthly meeting; this is part of what shapes us spiritually, along with our worship. In this model of membership, both of those formative experiences would be lost.

An additional concern was that a rationale listed for seeking NYYM membership directly is “not finding a spiritual home in an adjacent monthly meeting.” It was our sense that this could be a fairly common experience. Many of us have had the sense of being more or less connected to the spiritual life of our Meeting, depending on our own circumstances and/or the circumstances of the Meeting. It was M and C’s sense that working through these feelings as individuals in the context of community is a strengthening experience for both the individual and the community.

NYYM is asking for reactions to this APM proposal from individuals and/or Monthly Meetings. PRMM’s Ministry and Counsel committee thought that the issue of how one becomes a member of the Religious Society of Friends is important enough to warrant bringing concerns about the proposal to the entire Meeting.
